

## **2020 BILL RIDDLE CUTTING HORSE CLINIC-Athens, Ohio**

**Thursday September 24- through Sunday September 27, 2020.**

9:00 a.m.–5:00 p.m. daily. There will be two, two-day sessions.

Come join National Cutting Horse Association Hall of Fame trainer and internationally renowned clinician Bill Riddle, from Ringling, Oklahoma, a winner of over 4.5 Million Dollars, at a Cutting Horse clinic at Lavelle Farms [www.lavellefarms.com](http://www.lavellefarms.com) near Athens, Ohio.

The cost to ride is \$950.00 per horse and rider, per two day session, (Thurs-Fri. or Sat.-Sun. 9:00 a.m.-5:00 p.m. each day) which includes all fees: cattle charges, 30 amp camper hook-ups for riders if needed, stall rental and bedding. If space is available, one may ride all four days for \$1,900.00. Registrations are confirmed on a first-paid, first-served basis. Auditors and spectators are welcome, encouraged and may participate for free. **There will be a daily drawing for a free lesson on a trained cutting horse with Bill Riddle on the mechanical flag. One must join, or sponsor someone to join NCHA, to enter the drawing.** Work in the comfort of a fan-cooled covered indoor arena with good footing. There are no camper hook-ups available for spectators. Dogs may not be inside of the arena at any time. There is an indoor rest room with no showers. FFA Alumni group will have a concession trailer on the grounds during the clinic.

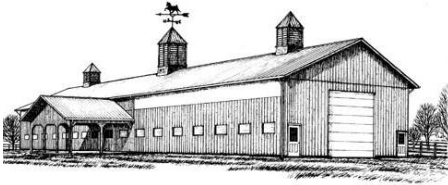
Bill plans to use both the mechanical flag and fresh cattle. He will cover many of the items in his training DVDs '*Beyond the Basics*' and '*Controlled Fundamentals*'. The provisions of Ohio's Equine immunity act shall apply. All participants must sign a liability waiver. First come(which means paid), first served. **All fees, (\$950.00) per two-day session, must be paid in full in advance to confirm rider spot** and are non-refundable. Anyone who needs to cancel after registering will be provided with a list of people wait-listed to contact to attempt to transfer spot. Checks should be made payable to '*Lavelle Farms*' and **mailed to 449 E. State St., Athens, Ohio 45701**. Credit card payments accepted with a 3% processing fee. Fill out the enclosed stall reservation form and the signed Release of Liability form and return by e-mail to [jlavelle@johnplavelle.com](mailto:jlavelle@johnplavelle.com) , or fax 740.594.3343 or regular mail at the address below with payment-in-full. Check in for the Thursday-Friday session is on Wednesday September 23, 2020 between 3:00 p.m. and 8:00 p.m. Special arrangements must be made for later arrivals. Weekend participants may check in between 5:00 p.m.-7:00 p.m. Friday September 25, 2020. Riders from the first session must plan on leaving by 5:00 p.m. on Friday unless special arrangements are made in advance to help insure stall space next to the arena for weekend participants.

## **STALL and RV RESERVATION FORM-Bill Riddle Cutting Horse clinic September 24-27, 2020.**

Indoor and initially bedded stalls are available for registered riders for the duration of the two day clinic. RV hook-ups and on-site camping are available with 30 amp power, water, but no sewer and are limited to those registered and enrolled to ride in the clinic. Costs are included with clinic registration. We are sorry there is no additional space on site for campers who are not riding in the clinic. An additional location exists nearby for auditors wishing to camp or for waste dump. No turn-outs are available. Indoor bathroom but no showers.

Local participants may trailer their horses daily. Check in begins on Wednesday evening, September 23, 2020 3:00 p.m. to 8:00 p.m. Special arrangements must be made for later arrival. For Sat-Sun. session riders, stalls should be available Friday after the clinic. Riders will be assigned a stall. No riding on the premises is permitted until Bill Riddle starts the clinic each day. Sorry, no dogs are permitted inside the arena or loose on the grounds.

**RELEASE AND WAIVER OF RIGHT TO SUE  
OR COLLECT DAMAGES.**

**Ohio Revised Code Section 2305.321(C)(2)(a)-Immunity as to equine activity risks  
Assumption of All Risks**

As a participant and/or spectator in equine related activities and clinics at Lavelle Farms, and the Rafter L Bar Arena, 3078 Fox Lake Road, New Marshfield, Ohio 45766 and all future events at this farm or facility with these or any other parties, including the owners, John P. and Lora Lavelle, any clinicians or trainers including Bill Riddle and Bill Riddle Cutting Horses, Inc. Ringling, Oklahoma, its and their helpers, assistants or workers, I do hereby agree that I am releasing and waiving my right to sue or recover and collect money for any damage or loss I, on behalf of myself, my heirs, my family or my estate, might sustain as a participant or spectator while using or visiting these premises or on any neighboring premises that may be involved including but not limited to those owned by Crabtree, Hawk, Stafford or Lavelle in Lee or Waterloo Townships of Athens County, Ohio from any or all of the parties. Under Ohio Revised Code Section 2305.321, an equine activity sponsor, participant, or equine activity professional, ***is not liable*** in a civil action for damages, for any of the risks associated with the activity, including, but not limited to the following: **a)the propensity of an equine to behave in ways that may result in injury, death, or loss to persons on or around the equine, b)the unpredictability of an equine's reaction to sounds, sudden movement, unfamiliar objects, persons, or other animals, c) Hazards, including, but not limited to, surface or subsurface conditions, d) A collision with another equine, another animal, a person, or an object, or e)the potential of an equine activity participant to act in a negligent manner that may contribute to injury, death or loss to the person of the participant or to other persons, including, but not limited to, failing to maintain control over an equine or failing to act within the ability of the participant. f)Tack and equipment breakage and failure that may result in death or injury.**

( A complete copy of this statute is available on-line for me to review. I understand I can withdraw from this clinic before I sign this release if I am unwilling to participate and receive a full refund of any money I have paid.) **CAUTION: Horses may rear, kick, flip over backwards, bite, strike, run-off, spook, fall down, break equipment, get tangled up in rope or equipment, run into an object or another horse and do other things which could cause severe injury. By signing this release, I am assuming all of these risks and any other risk which is inherent in the activity.**

3. Keeping all of the foregoing risks that are known and any other unknown potential risks in mind, I am freely and voluntarily participating in equine related events at Lavelle Farms. By my signature below, that I am expressly agreeing as follows:

1. On behalf of myself, my estate and my heirs, to release and waive any right to sue and/or collect from John P. and Lora A. Lavelle, Lavelle Farms, and any and all clinicians, including Bill Riddle and Bill Riddle Cutting Horses, Inc.

Ringling, Oklahoma, its and their trainers, agents, helpers, sponsors or employees of the above, for any and all liability for any injury I might receive or any damage I might sustain in this equine activity. This shall include, but is not limited to the following:

- (1) Damages I might incur for medical bills, lost wages, out-of-pocket expenses;
- (2) For pain and suffering;
- (3) Nominal damages
- (4) Punitive damages;
- (5) Any recovery I might have had for monetary damages, for myself, my horse or property.

11. This Release and Waiver is made on behalf of myself, my spouse, if any, my heirs, executors, administrators, subrogees and assigns. Or on behalf of my child or children, if they participate at any equine related event at the facility or on the premises.
12. I also covenant not to sue John P. and Lora A. Lavelle, Lavelle Farms, Bill Riddle and Bill Riddle Cutting Horses, Inc. Ringling, Oklahoma or any of his/her/their/its employees, agents, volunteers or helpers for anything including any claimed act of negligence, for any medical bills, lost wages, pain and suffering, or any other type of damage or claim. And I make this covenant on behalf of myself, my heirs, my children, administrators, executors, assigns and subrogees.
13. I further agree to indemnify and hold John P. and Lora A. Lavelle, Lavelle Farms, and any and all clinicians, including Bill Riddle and Bill Riddle Cutting Horses, Inc. Ringling, Oklahoma, its and their trainers, agents, helpers, sponsors or employees of the above, harmless from any liability for negligence, misfeasance, or for any other reason. And I do so on behalf of my heirs, children, executors, administrators and assigns.
14. Under Ohio's Equine Immunity Act (O.R.C. § 2305.231) and the common law, I am waiving any and all rights to sue or collect damages and I do hereby voluntarily consent to participate and I agree to assume all risks. This release remains valid until revoked in writing. **A copy of this release with a facsimile signature shall serve the same purposes as the original.** I also do so as a parent, natural guardian and next friend of any of my children who are minors under the age of 18 who participate in any event at this location.
15. I understand that no riding helmets are being provided. I agree to assume the risk of riding with or without a helmet on behalf of myself and any minor child. I understand a helmet may be used if desired. I agree to act at my own risk.
